In pursuance of the letter issued by the Office of the Director of Higher Education, Government of Assam vide No. 550356/2024/1 dated 18.10.2024 regarding issuance of No Objection Certificate (NOC) to college employees for applying for admission to courses of higher studies and for other jobs, it is hereby informed to all concerned that the University has decided to adhere to the aforesaid letter.

The letter states that: *“The Governing Body shall issue No Objection Certificate to the college employees for applying for admission to courses of higher studies and for other jobs,”* as per Rule 24 of the Assam College Employees (Provincialisation) Rules, 2010.



Sub: Regarding No Objection Certificate to the college employees for  
applying for admission to course of higher studies and for other jobs.

Sir,

With reference on the subject cited above, I am directed to state that various queries are often received from the Principals of colleges/ University officials regarding the issue of No Objection Certificate (NOC) to the college employees for applying for admission to courses of higher studies and for other jobs.

Rule 24 of the Assam College Employees (Provincialisation) Rules, 2010, states, "***The Governing Body shall issue No Objection Certificate to the college employees for applying for admission to courses of higher studies and for other jobs.***"

Accordingly, this Directorate vide letter No.DHE/CE/UGC/Circular/136/2017/76, dated 24-10-2018 issued a letter that **the Governing Body shall issue No Objection Certificate to the college employees for applying for admission to courses of higher studies and for other jobs.**

But Govt. letter issued vide No.AHE.498.2018.59, dated 14-06-2022, directed "*...Higher Education Department in partial modification of all earlier orders/ communications has notified that henceforth teaching and non-teaching staffs of all categories of colleges will not require any NOC from concerned Colleges/ Universities/ Polytechnics for applying for any other posts in any Government organisation. However, any aspiring candidate may intimate to the respective Colleges/ University authorities for his/her applying for any post under any organisation including State/Central Government. This shall be immediately brought in the knowledge of respective authorities.*"

However, Hon'ble Gauhati High Court passed an order dated 17-03-2023 in WP(C) No.1503/2023 filed by Dipti Sikha Nath -Vs- The State of Assam and 2 Ors. and directed that "*Considering the law laid down by the Hon'ble Apex Court, noted above, in the interim, the communication No.AHE.498/2018/59, dated 14-06-2022 issued by the State Government in the Higher education Department regarding non requirement of 'No Objection Certificate' for the Governing Body of a provincialsied College by an incumbent serving in said College for his/her application to any other post in any Government organization shall remain suspended until further order of the Court.*"

In view of the above, Rule 24 of the Assam College Employees (Provincialisation) Rules, 2010, which states that "***The Governing Body shall issue No Objection Certificate to the college employees for applying for admission to courses of higher studies and for other jobs***" is to be adhered to by all concerned.

This is for your kind information and necessary action.
